- The settler hereby conveys the sum of Rs.5,000/-for the creation of the Trust unto himself and the following persons as above mentioned:-

5. Object of the Trust -

- b) To organize resources for the development and creation of opportunities for various voluntary employment and livelihood among the poorest of the communities residing in rural as well as urban slums, in the areas or cities / towns in the state of Jharkhand or any other part or parts of India where services are called for or required.
- c) To provide educational aid and in the form of equipment and scholarship to the poor, deserving students without considering gender.
- d) To promote, supervise and carry out by itself or through other persons or Institutions, any educational medical or relief and rehabilitation of the poor effected by storms, flood, earthquakes etc and other charitable works including establishment of old age. Home for the public at large who are needy and poor.
- e) To establish, maintain or grants aid for the establishment and/or maintenance of park, gardens, gymnasiums, sports clubs, Dharamsala and rest houses, for use by public in general.

- f) To implement various schemes of state as well as Central Government under "Women & Child Welfare Scheme, ST/SC Welfare Scheme. Welfare Schemes for minorities and all other schemes promoted for the welfare of poor and needy.
- g) To give aid by way, of donations to different charitable trusts, institutions, societies or organization in India, for charitable and development purposes for the poor and needy people.
- This shall be public Charitable Trust and the benefits of this Trust shall ensure to the public without distinction of Caste, religion etc.
- 7. The trust created by the Settlor is not and shall not be revocable.
- The funds and income of the Trust shall be utilized towards the achievement of the objects.
- The salary amount shall be given to the trustee who will give his full time to the benefit of the Trust and which will be fixed by Board of Trustees.
- The Management of the Trust shall vest in the Board of trustees comprising initially of following persons, who shall be Called founder trustees also
 - (1) Abani Bhushan Ram
 - (2) Sanjay Kumar Lal
- The total number of Trustees shall not exceed ten and should not be less than two.
- All the trustees shall be residents in India and any trustee who leaves India permanently shall vacate his office.
- 13. A trustees cease to hold the office :-
 - (a) On the death.
 - (b) On his resignation
 - (c) On his becoming insane,
 - (d) On his becoming insolvent.
 - (e) On his being expelled by the Board of trustees, for acting or having acted against the interest of the trust by a majority vote, provided such trustee has been given a reasonable opportunity

- 14. The Board of Trustees shall elect one among themselves as the MANAGING TRUSTEE and such a person shall hold the office till he resigns. The Board of trustees shall also determine the powers, duties, responsibilities and other terms and conditions connected therewith. The Board of trustees shall have power to vary the terms and conditions of his office.
- 15. 8mt. Jaisri Devi wife of Sanjay Kumar, will be Chairman and Abani Bhushan Ram Son of Dinesh Ram shall be Secretary of the Trust and remuneration will be given to aforesaid as decided by the Board.
- 16. With a view to carrying out of the objects of the Trust herein above mentioned and to manage and administer the trust funds and without prejudice to the generality of any power whereby or by law conferred on, implied or voted in the Board of Trustees, the Board of trustees shall have the following powers.
 - a) To apply and use the funds for all or any of the objects of the trust and/or to accumulate the surplus applied portion of income and invest the same, subject to the provision of the Income tax Act, 1961 as amended from time to time, relating to accumulation of income and investment thereof funds of the trust shall be invested according to the modes prescribed under the Income Tax Act, 1961.
 - b) To receive any money or other assets in any shape or form as gift or donation and to hold the same as capital fund and/or apply it for furthering the same.
 - To receive security and apply it as per law.
 - d) To invest the funds from time to time In such manner as may be decided upon by the Trustees from time to time to dispose of alter or vary the Investments from time to time to realise the Investments in conformity with the provisions of the Income Tax Act.
 - To compromise, compound, abandon, submit to arbitration or otherwise Institute any actions suits, proceedings, Claims or other things. Whatsoever arising out of the administrators of the trust

fund and to enter into execute and do, such agreement, instruments and composition or arrangements, releases and other things as may seem expedient without being liable or responsible for any loss occasioned by any act or thing so done by them in good faith.

- f) To acquire or to dispose off through mortgage hire, lease or otherwise movable or Immovable, tangible or intangible properties, and rights and benefits and to manage the same.
- g) To receive, collect or realise or cause collection or realisation of all income that acrue or become due on all or any Investments and to grant receipts and discharges.
- To represent the trust in all courts original and appellate or before judicial or quasi- Judicial authorities and other authorities, departments of Government, semi-Government or local authority.
- To open and maintain accounts with Schedule bank and operations of such accounts shall be by Managing trustee, Secretary and treasurer jointly and without signatures of all three of aforesaid no amount shall be withdrawned from the Trust account and Trust account will be opened in the name of the aforesaid Managing trustee, Secretary and Treasurer and amount will be withdrawned by Cheque.
- To sign and verify all pleadings, memorandum or appeal, petitions and applications of all kinds and to engage lawyers and other professionals and to take all such other necessary steps.
- k) To borrow or raise any money that may be required by the trust upon such terms as may be deemed fit and secure any moneys so borrowed by Mortgage or charge of all or any part of the asset belong to the Trust
- To pay out of the "Trust funds, salaries, wages, rent, building maintenance, repairs and other expanses relating to the trust, its administration, management of its activities or its other affairs.
- To start a business of purchasing the goods and sale in profit on behalf of the Trust and the profit amount shall be of Trust.

- n) To start a scheme for benefit of the Trust.
- To appoint and/or dismiss staff executives, officials, caretakers, attendants and other employees on such terms as the Board may think fit.
- P) To appoint committees or sub-committees from among the members of the Board and or alongwith others and assign duties and to frame with such rules or business as the Board shall think fit, and to alter or vary the same from time to time, provided that such rules of business shall have be inconsistent with the terms of these presents, the Board shall be entitled to frame, constitute and regulate the procedures of such committees or sub-committees.
- q) To decide all questions arising in the administration of trust and including all questions relating to the interpretation of these presents the administration of the any institution maintained by the trust or concerning any thing or any matter relating to, connected with or arising out of these presents or the operation thereon. The decision taken by the Managing trustee and Secretary in all or any of the matters aforesaid shall be final.
- r) The Board of Trustees shall conduct the activities of the trust in accordance with the stipulations set out herein the Board of Trustees may delegate all or any of the powers vested in them to such person(s) For such period as they may deem fit and may at any time revoke, vary, after, such powers so delegated. But last power to do the aforesaid shall be in the hand of Managing trustee and Secretary.
- The trustees have power to frame such bye-laws, subsidiary rules and regulations and shall have further power to add, delete or amend the same from time to time as may necessary for the conduct of their business provided that the rules and regulations so framed and the amendments to the effect are not inconsistent with the objects of the trust and also the provisions of the Income Tax Act, 1961 Governing Charitable Trusts.
- t) The persons enumerated in these presents shall be exercised by the Board strictly in conformity with the conditions laid down in the

Income Tax Act, 1961 (43 of 1961) amended from time to time, so that the income of the trust will be exempt from the Income Tax and the donors will get deduction in respect of their donations under Section 80 G of the Income Tax Act, 1961 for each and every assessment year.

- To do all other acts, deeds, matters and things which may be deemed necessary for carrying out the objects of this Trust or its administration.
- 17. The Board of trustees may appoint an Treasurer from among the Trustees. The Treasurer shall keep or cause to be kept proper books of accounts and records or cause to be audited once a year by a Chartered Accountant and the salary of the treasurer shall be fixed by the Board.
- 18. The official year of the trust will be the financial year,
- All provisions of this deed of Trust as well as any rules and regulations framed by the Trustees shall be interpreted by the trustees.
- 20. The managing Trustee shall guide and direct the Secretary in regard to the administration of the Trust. The secretary shall be responsible to the Managing Trustee and the Board of Trustees in the absence of the Secretary, the Managing Trustee shall direct any other trustee to perform the duties of the Secretary.
- The Trustees shall meet as often as necessary to transact the business of the Trust. There shall at all cost be two meetings of the Trustees in a year.

The Secretary shall convene the meetings, in consultation with the Managing Trustee. The Secretary shall be responsible to record the minutes of the meeting and to carry out the directions given or decision taken in such a meeting. He shall report to the Managing Trustee and the Board of Trustees the action taken by him in implementing the direction of the Trustees.

22. a) The decision of the Board of Trustees shall be taken on the basis of majority votes, in the case of equality of votes, the managing Trustee in a meeting shall exercise a casting vote, in case of dispute the Managing Trustee shall have power to decide the dispute. Jaysharae Dew

- The quorum for a meeting shall be 2. If there is no quorum, the b) meeting could be adjourned and the requirement of quorum shall not apply for such adjourned meeting.
- It shall be opened to the Board of Trustees to adopt any resolution c) by circulating the same among the Trustees. Provided such a resolution is assented to by a majority of the Trustees. All the resolutions adopted by circulation shall be placed in the immediately next meeting of the Board of Trustees for recording the same.
- Every Trustee and the Secretary of the trust shall be indemnified from out of the funds of the Trust against all the loss or expenses incurred in the discharge of his duties, except such as has happened through his willful negligence or dishonesty.
- 24. All legal proceedings by or against the trust shall be instituted in the name of the trust through its Managing Trustee.
- The trustees shall have the power to alter or amend the provisions of this 25. deed of Trust, provided that such alteration or amendment shall not be inconsistent with the object of this trust as well as the provisions of the Income Tax Act, 1961 governing the Charitable Trusts, provided further that the amendments shall not be given effect to unless approved by the Commissioner of Income Tax.
- It is hereby declared that the Managing Trustee and Secretary shall have 26. power to dissolve the Trust by 2/3 majority of vote. Managing Trustee, Secretary or any one Trustee duly authorised by the Board of Trustees shall have power to execute any document required to be registered under the law and it is further declared that such document shall be deemed to have been properly executed by the Trust.
- It is hereby declared that the Trustees have the power to dissolve the 27. Trust by 3/5 majority of vote and In such event, the assets remaining on the date of dissolution shall under no circumstances be distributed among the trustees, but the same shall be transferred to another charitable Trust, whose objects are similar to those of this Trust.


